SEBI vide its Circular No. SEBI/HO/MIRSD/DOP1/CIR/P/2018/73 dated 20th April, 2018 has directed to listed companies to update Bank Account details of the shareholders for payment of dividend. SEBI has made it mandatory for payment of dividend through electronic channels RTGS/ NEFT to facilitate direct credit to shareholders' account. ## PAN updation:

SEBI has also made it mandatory to record the PAN details in shareholders folios. Shareholders holding shares in physical form, shall send a legible copy of PAN card duly self-attested to R & T Agent M/s. Link Intime India Pvt. Ltd.

### Transfer of shares in Physical Form:

SEBI vide Notification No. SEBI/LAD-NRO/GN/2018/24 dated 8th June, 2018 stipulated that transfer of shares in physical form will not be allowed <u>after 5th December</u>, 2018, and will be processed only in dematerialised form. In view of the aforesaid condition, you may look into dematerialization of shares to avoid inconvenience as transfer of shares in physical form will not be permitted, effective 6th December, 2018.

## Nomination:

Shareholders holding shares in physical form may register the nomination by using the nomination facility.
