Sub: **Capital Expenditure proposal approved by the Board of Directors**

Pursuant to Regulations 30 of the SEBI (Listing Obligations and Disclosure Requirement) Regulations, 2015, this is to inform you that the Board of Directors at its meeting held today i.e. 18th May, 2021 has approved the investment of Rs.240 crores to strengthen its competitive position in tyre reinforcement market by modernization of plant, and augmenting capacity by ~30% and Rs.23 crores for increasing the capacity of draw texturized yarn and mother yarn.

The details required under the provisions of Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 is as under:

a) Existing Capacity	Not applicable, as there is no defined capacity for such type of plants, which will vary from different products produced from time to time.
b) Existing capacity utilization	90-100%
c) Proposed capacity addition	there is no defined capacity as it varies from products produced, from time to time.
d) Period within which the proposed capacity is to be added	~2 years
e) Investment required	263 crores
f) Mode of financing	Mix of Debt and internal accrual
g) Rationale	To have necessary assets for upcoming business opportunities
