Sub: COVID-19 - Intimation regarding plant operations (Bharuch Site Plant) under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements), Regulations 2015

Dear Sirs,

This is with reference to the Company's letters dated 23rd March, 2020 and 25th March, 2020 (pursuant to Regulation 30 of SEBI LODR) informing about temporary shutdown of plants operations at Pune and Bharuch sites due to COVID-19 pandemic.

The Collector of Bharuch District, (Gujarat) vide letter Ref. DISASTER/CORONA/ VASHI/dated 20th April, 2020 permitted the industries as listed out in the said letter in Bharuch District including the Company's plant Rajashree Polyfil (Bharuch site) to commence manufacturing operations, subject to compliance with the guidelines forming part of the letter and issued by the Government of India, observing standard operating conditions and procedure and permissions from various local authorities to meet the conditions for operation of the plant.

The Company has obtained the requisite permissions from various authorities and has started the operations of Bharuch Site in stages from 30th April, 2020. Ramping up of the operations will depend upon availability of essential services and supplies and market condition.

Considering the prevailing uncertainties, it is difficult to ascertain the impact arising out of suspension of operation.
