## Sub: <u>Intimation under Regulation 30 of the SEBI (Listing Obligations and Disclosure</u> <u>Requirements) Regulations, 2015 (`Listing Regulations')</u>

This is with reference to our earlier communication to the Stock Exchange dated 27th February 2025, regarding the fire incident at the NFY Spinning Plant Unit-Rajashree Polyfil, Rajashree Nagar, Post Umalla, District Bharuch, Gujarat – 39312, and the subsequent update dated 18th April 2025, concerning the imposition of an interim Fire Accident Environment Compensation of Rs. 36,00,000 (Rupees Thirty-Six Lakhs) and the requirement to submit a Bank Guarantee of Rs. 2,50,000 (Rupees Two Lakhs Fifty Thousand).

We wish to inform you that the Company has paid the interim compensation of Rs. 36,00,000 and has submitted the Bank Guarantee of Rs. 2,50,000, as directed.

Pursuant to section 31-A of the Air (Prevention and Control of Pollution) Act-1961, the Gujarat Pollution Control Board has granted permission to resume operations at the NFY Spinning Plant. Accordingly, the Company will commence operations at the NFY Spinning Plant in a phased manner.
