Dear Sirs,

This is with reference to the Company's letters dated 23rd March, 2020 and 25th March, 2020 informing about temporary shutdown of plants operations at Pune and Bharuch sites due to COVID-19 pandemic.

The Government of Maharashtra, Department of Revenue and Forest, Disaster Management, Relief and Rehabilitation, Mantralaya, Mumbai-400032 vide its order bearing no.DMU/2020/CR.92/DisM-1 dated 14<sup>th</sup> May, 2020 permitted to operate industrial units in Pimpri-ChinchwadMunicipal Corporation (PCMC) area, subject to compliance with the guidelines mentioned in the said order.

Based on the above order the Company has started the operations of Pune Site Plant from 26<sup>th</sup> May, 2020. The operations will scale up gradually in phased manner. However, ramping up of the operations will depend upon availability of essential services, supplies, market condition and relaxation in the conditions of the aforesaid order.

Considering the prevailing uncertainties, it is difficult to ascertain the impact arising out of suspension of operation.
