**Oversight:** The Managing Director signing this Policy is accountable for the Policy and the Unit Heads are responsible for implementing the policy at their respective sites.

Every Century Enka Ltd. unit endeavour to achieve this by:

- Adopting latest Information security practices and maintaining positive legal compliance to applicable IT security
  regulations for protecting our people, information, intellectual property, assets, activities and facilities against
  misuse, loss, damage, disruption, interference, espionage or unauthorized disclosure.
- Ensuring access to information only to authorised persons and providing competent and adequate resources.
- Identifying IT security risks and hazards and assessing & managing such risks to as low as reasonably practicable
  at all facilities with participation of all employees at various stages including the planning phase of acquisitions,
  mergers and new projects.
- Ensuring adequate emergency response capability in case of emergency.
- Measuring, monitoring and benchmarking of IT security related practices and infrastructure & recovery programmes as required.
- Training and systematic development of employee skills ensures that we are always up to date with current needs.
- Undertake internal and third-party audits at regular intervals to assess IT security performance and conduct due diligence during mergers and acquisitions, new projects.
- Communicate this Policy within the Organisation. Develop and follow an appropriate communication framework to

  related priorities, their links to global issues and initiate actions on key IT security challenges.
